Citizens of Bingham and Moscow,

Good news the General Purpose Aid that the district receives from the State of Maine increased by \$88,919.09. This helped to offset the increases that are occurring. The district completed the process of enrolling in MaineCare. The enrollment process took a little over a year. But due to a very dedicated special education staff that persevered we are now able to bill MaineCare. This newly generated revenue assists in offsetting the increases that the district has experienced in special education. The MaineCare revenue allowed the district to increase carryforward by \$100,000. This is MaineCare revenue that was generated during the 2023-2024 school year. We are estimating that the district will receive approximately \$100,000 in MaineCare revenue in the 2024-2025 school year. These increases in revenue are allowing us to create a decrease in the additional local that each municipality must raise to fund the budget. The decrease to Bingham will be \$59,618.84 and Moscow's decrease will be \$34,749.25 with a total decrease to the communities of \$94,368.09

The proposed district budget has increased. The budget includes a lease purchase for a new gasoline bus to replace a 2014 bus. The district was approved by the State of Maine to lease/purchase the new bus which means the district will receive up to \$116,650 in additional state funding for the purchase of the bus. The revenue for the bus will be received through the districts' general purchase aid in the amount of \$23,330 for the next five years. One other item that the district needs to invest in is the purchase of new financial software. The cost for the new software is \$26,520. The financial software that the district is currently using is not going to be supported in the future. The district must have financial software in order to pay employees and vendors.

MSAD 13 is experiencing increases in diesel fuel, water, electrical rates, property, liability, and health insurances as well as the cost of maintenance and repairs for equipment and buildings. We anticipate these costs to continue to increase. Minimum wage continues to increase with the passing of LD 974 that will require that all Educational Technicians be paid 125% of minimum wage. This will increase the starting pay for educational technicians based on current minimum wage of \$14.15 to \$17.68 per hour. LD 974 requires that all support staff be paid at least 115% of minimum wage or \$16.27 per hour. These increases are scheduled to begin on July 1, 2025 thus impacting the 2026 budget. By then the minimum wage could increase again making the increase larger.

District enrollment has remained steady this year at approximately 170 students. This is a decrease of approximately 10-15 students from the 2022-2023 school year. This may lead to a decrease in General Purpose Aid, state funding in the 2025-2026 school year as the district funding is based on property valuation and the number of students.

# Upper Kennebec Valley Junior/Senior High School

#### **Dual Enrollment College Credits**

Our students have access to courses through the University of Maine system and Maine community colleges. Valley teachers supervise these courses and assist students in communicating with their professors. Students earn high school and college credits

#### **Advanced Placement Courses**

Valley offers AP courses in history and art. Students earn high school credit for these courses and also may earn college credit.

#### **Technical Training**

Valley partners with Somerset Career and Technical Center to provide students with training for a variety of careers:

Welding, Electrical, Carpentry, Nursing, Culinary, Automotive, EMT, Pre-engineering, Outdoor Leadership, CDL, Early childhood education





#### **Outdoor and Agricultural Education**

Teachers have utilized grant money to fully equip outstanding outdoor and agricultural education programs. This includes gardening equipment, aerial and underwater drones, camping and ice fishing equipment, trail cameras, and a fleet of canoes.

#### **Baker Mountain Partnership**

The school has partnered with local non-profit Baker Mountain, gaining access for students to complete lessons and activities at the mountain and lodge during the school day. Our sports and fitness classes have used Baker for day hikes, and our Maine woodsman and Wildlife Studies students completed an overnight camping trip on the mountain.

#### **Douglas Arno Building**

Valley fully renovated the shop building and reopened it to students for the 2023-24 school year. The building includes a weightroom, classroom, and workshop space for students to complete hands-on projects.

# **MSAD 13 Special Education**

All general education teachers provide differentiation, accommodations, and modifications to <u>maximize</u> <u>the time students with disabilities</u> <u>spend in general education class-</u> <u>rooms</u>.

Our district contracts with outside providers to deliver <u>school-based</u> <u>occupational therapy</u> and <u>speech</u> <u>therapy</u> for special education students.



<u>Cav Cast</u> is an elective class taught by a special educator. It is open to all 7<sup>th</sup> & 8<sup>th</sup> grade students.



This Year CavCast, a digital media class taught by Craig Turcotte, received a \$1900 Teach With Tech Grant from the Maine Learning Technology Initiative. The money was used to purchase three GoPro cameras, upgraded microphones, and a DJI Mini III drone. In CavCast, students learn to film and edit video which can be used for academics, future careers , or their own personal use. The class is open to seventh and eight graders at Valley Middle School. Students' work can be seen at CavCast-You Tube.

Special education teachers (K-4, 5-8, 9-12) provide resource room support for students with disabilities in math, reading, writing and social skills as ordered by IEP teams.

#### Day Treatment Program

We have recently started a day treatment program for students who require more intensive supports. This effort allows us to keep students in the district rather than using Special Purpose Private Schools to deliver the services. This is a significant service to the community as we are able to bill MaineCare for the behavioral health services we are providing.

We have a full-time clinical school social worker who provides <u>school-based thera-</u><u>py</u> to our general and special education student populations.

The <u>Cavalier Cupboard</u> is a school-based food pantry open to both the school community and other community members.



Both special education and general education students help unload the deliveries from the Good Shepherd Food Bank and organize and stock the shelves for community members to have easy access to product. On average, over <u>6,000</u> <u>pounds of food</u> and other items are delivered monthly.

Article 1 – Elect a moderator to preside at the meeting.

Article  $2 - \underline{\text{LINE I}}$ -REGULAR INSTRUCTION Includes all elementary (PK-8) and secondary (9-12) education which includes negotiated teacher salaries, along with benefits and substitute teachers for both schools. Included are the cost of textbooks, instructional supplies, equipment, laptops, and the Gifted & Talented Program.

Article 3 -<u>LINE II-SPECIAL EDUCATION</u> – Includes all special education services for grades PK-12. Negotiated salaries and benefits for teachers, educational technicians, special services director and secretary along with instructional supplies, special equipment and special services to include occupational therapy, physical therapy, evaluations, psych/testing, speech and language, and out of district placement tuition and transportation costs. Money from this article is used to meet student needs under the Federal Americans with Disability Act and Section 504.

Article 4 – <u>LINE III</u>-CAREER & TECHNICAL EDUCATION Cost of tuition for high school students to attend Somerset Career and Technical Center at MSAD #54 is paid directly by the State of Maine.

Article 5 – <u>LINE IV</u>-OTHER INSTRUCTION Includes stipends for coaches, athletic director, contracted services, official fees, supplies, and uniforms for all co-curricular and extra-curricular programs for Valley Jr/Sr High School to include athletic programs plus student council, prom, and yearbook.

Article 6 – <u>LINE V</u>-STUDENT AND STAFF SUPPORT – Negotiated salaries and benefits for instruction support personnel to include technology, nurse, and guidance counselor. Supplies for testing of students, medical and educational supplies.

Article 7 – <u>LINE VI-SYSTEM ADMINISTRATION</u> – School Board Directors, Superintendent, Administrative Assistant, Bookkeeper salaries and benefits along with legal, audit, insurance, advertising for vacancies, accounting software support, supplies, and equipment.

Article 8 – <u>LINE VII</u>-SCHOOL ADMINISTRATION – Negotiated salaries and benefits for Principals, Administrative Assistants, and the cost to operate each office including attendance and grading software.

Article 9 – <u>LINE VIII</u>-TRANSPORTATION – Negotiated salaries and benefits for bus drivers. Maintenance and fuel for the bus fleet is included.

Article 10 – <u>LINE IV</u>-FACILITIES MATINENANCE – Negotiated salaries and benefits for custodians. All utilities and supplies to operate the district's facilities and the revolving loan payment.

Article 11 – LINE X-DEBT SERVICE AND OTHER COMMITMENTS - Covers Debt Service and Other Commitment.

Article 12 – <u>LINE XI-ALL OTHER EXPENDITURES</u> – Article covers the additional cost to operate the school lunch program for grades K-12.

Article 13- LOCAL EPS FUNDS APPROPRIATED/RAISED-The school administrative unit's contribution to the total cost of funding public education from pre-kindergarten to grade 12, as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount the district must raise and assess in order to receive the full amount of state dollars.

Article 14 – NON-STATE FUNDED DEBT SERVICE-Covers annual payments on long-term debt major capital school construction projects that are not approved for state subsidy. The bonding of this long-term debt is previously approved by the voters or other legislative body.

Article 15 – **ADDITIONAL LOCAL FUNDS**-The additional local funds are those locally raised funds over and above the school administrative unit's local contribution to the total cost of funding from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding act, and local amounts raised for the annual payment of non-state funded debt service that will help achieve the District's budget for educational programs.

Article 16 – **TOTAL SCHOOL BUDGET SUMMARY-**This is a summary article. This allows the directors to expend state, federal and other aid and grants they may receive during the fiscal year, provided these funds do not require expenditure of local funds not previously appropriated.

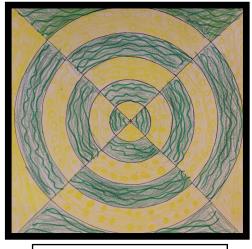
Article 17 - ADULT EDUCATION-Covers Adult Education costs.

Article 18 - TRANSFERS - Allows the Directors to transfer from one line to another line to cover an emergency.

Article 19 – **STATE AGENCY CLIENT FUNDS** – Allows the Board of Directors to accept and expend monies received for State Agency Clients.

Article 20 – **EXPENDITURE OF GRANTS AND OTHER RECEIPTS** - Allows the Board of Directors to expend monies received from federal and state grants and programs or other sources.

Article 14: <u>Non-State Funded Debt Service.</u> To see what sum Maine School Administrative District No. 13/RSU 83 will raise and appropriate for the annual payments on debt service previously approved by the legislative body for non- state-funded school construction projects, non-state-funded portions of school construction projects in addition to the funds appropriated as the local share of the school administrative unit's contribution to the total cost of funding public education from kindergarten to grade 12.

Explanation: Non-state-funded debt service is the amount of money needed for the annual payments on the District's long-term debt for major capital school construction projects that are not approved for state subsidy. The bonding of this long-term debt was previously approved by the voters or other legislative body.

#### Article 15: Additional Local Funds. (Written Ballot Required) Shall Maine School

Administrative District No. 13/RSU 83 raise and appropriate \$1,080,870.27 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$1,080,870.27 as required to fund the budget recommended by the Board of Directors. These funds cover costs of District schools that the state's funding model does not recognize.

Explanation: The additional local funds are those locally raised funds over and above the school administrative unit's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the District's budget for educational programs.

#### Article 16: Total School Budget Summary. To see what sum Maine School Administrative

District No. 13/RSU 83 will authorize the Board of School Directors to expend for the fiscal year beginning July 1, 2024 and ending June 30, 2025 from the school administrative unit's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

Article 18: <u>**Transfers.**</u> To meet emergency or unexpected needs, shall the District authorize the Board of Directors to transfer not more than 5% of each budget expenditure line approved by the District voters to other budget expenditure lines, provided that such transfers shall not increase the total amount of this budget?

Board of Directors recommends a "YES" vote.

Explanation: This allows the Directors to transfer up to 5% of any line into another line to cover any emergency. An example of an emergency would be the breakdown of a boiler and the costs to repair/ replace. Such a transfer would be made by a majority vote of the Board of Directors at a special or regularly called Board of Directors meeting. This would also save the expense of holding a special referendum vote if a transfer within the established limit could cover the need.

Article 19: <u>State Agency Client Funds.</u> Shall Maine School Administrative District No. 13/RSU 83 be authorized to expend, in addition to the amounts authorized in Article 16 (Summary Article), any additional funds received by the District from the State of Maine for State Agency Clients? Board of Directors recommends a "YES" vote.

Explanation: This article allows the Board of Directors to accept and expend monies received for State Agency Clients because State Agency Clients monies are considered flow-through, so it is not necessary to raise local tax money.

Article 20: <u>Expenditure of Grants and Other Receipts.</u> In addition to amounts in the preceding articles, shall the Board of Directors be authorized to expend federal stabilization funds and such other sums as may be received from federal and state grants or programs or other sources during the fiscal year for school purposes, provided that such grants, programs or other sources do not require the expenditure of other funds not previously appropriated?
